### Canadian Union of Public Employees Employees' Pension Plan

#### AMENDMENT NO. 76

#### WHEREAS

The *Plan* is amended by Resolution of the Settlers, to which this amendment is attached, to address the coming into force on January 1, 2016 of amendments to Quebec's *Supplemental Pension Plans Act*.

#### NOW THEREFORE,

by Resolution of the Settlers, the amendment to the *Plan*, effective January 1, 2016, is as follows:

1. Section 9.8 is added as follows:

#### **"Transfer of Benefits for a Quebec Member**

Where a Quebec *member* elects to transfer his benefit entitlements under this Section 9, the provisions of Quebec's *Supplemental Pension Plans Act* providing for the value of benefits to be paid out of a pension fund only in proportion to the degree of solvency of the plan in full and final settlement of benefits under the plan shall not apply."

2. Section 10.8 is added as follows:

#### **"Transfer of Benefits for a Quebec Member or Former Member**

Where the *spouse*, designated *beneficiary* or estate of a Quebec *member* or former *member* elects to transfer his benefit entitlements under this Section 10, the provisions of Quebec's *Supplemental Pension Plans Act* providing for the value of benefits to be paid out of a pension fund only in proportion to the degree of solvency of the plan in full and final settlement of benefits under the plan shall not apply."

3. Section 16.7 is added as follows:

#### **"Transfer of Benefits for a Quebec Member**

Where a Quebec *member* or *member's spouse* elects to transfer his benefit entitlements under this Section 16, the provisions of Quebec's *Supplemental Pension Plans Act* providing for the value of benefits to be paid out of a pension fund only in proportion to the degree of solvency of the plan in full and final settlement of benefits under the plan shall not apply."

4. Section 17.3 is added as follows:

**“Transfer of Benefits for a Quebec Member**

Where a Quebec *member* elects to transfer his benefit entitlements under this Section 17, the provisions of Quebec's *Supplemental Pension Plans Act* providing for the value of benefits to be paid out of a pension fund only in proportion to the degree of solvency of the plan in full and final settlement of benefits under the plan shall not apply.”

5. Section 18.6 is added as follows:

**“Transfer of Benefits for a Quebec Member**

Where a Quebec *member* elects to transfer his benefit entitlements under this Section 18, the provisions of Quebec's *Supplemental Pension Plans Act* providing for the value of benefits to be paid out of a pension fund only in proportion to the degree of solvency of the plan in full and final settlement of benefits under the plan shall not apply.”
